Adoption Statement Forest of Dean District Allocations Plan (2006 - 2026) Adopted June 2018.

In accordance with Regulation 26 of The Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), notice is hereby given that the Forest of Dean District Allocations Plan (2006 - 2026) Adopted June 2018 was adopted by Forest of Dean District Council on 28 June 2018.

Subject Matter: The Forest of Dean Allocations Plan (2006- 2026) Adopted June 2018 (from here on referred to as the Allocations Plan) together with the the Core Strategy, Cinderford Northern Quarter Area Action Plan and any made neighbourhood plans form the Local Plan for the Forest of Dean District and will guide future planning applications. The Allocations Plan shows how the Core Strategy document will be implemented; showing detailed sites identified for development, protected areas and settlement boundaries. The Allocations Plan replaces the remaining parts of the Forest of Dean Local Plan Review 2005.

Mr Brendan Lyons BArch MA MRTPI IHBC, an Inspector appointed by the Secretary of State, undertook the independent examination of the Allocations Plan following submission on 28 August 2015. The Inspector's Report was received by the Council on 20 June 2018. The Inspector concluded that with Main Modifications the Allocations Plan satisfies the requirements of Section 20(5) of the Planning and Compulsory Purchase Act 2004 and meets the criteria for soundness in the National Planning Policy Framework. The adopted Allocations Plan includes the Inspector's Main Modifications. It also includes Additional (minor) Modifications that (taken together) do not materially affect the policies of the Plan.

Challenge: Any person aggrieved by the adoption of the Allocations Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004, on the grounds that:

- a) The document is not within the appropriate powers conferred by Part 2 of the Planning and Compulsory Purchases Act 2004
- b) A procedural requirement has not been complied with.

An application must be made no later than the end of the period of six weeks starting with the date of adoption of the Allocations Plan.
