*In accordance with Neighbourhood Planning (General) Regulations 2012, Part 5, 14(a)-(c) notice is hereby given that a formal pre-submission **public consultation on the Draft Mitcheldean Neighbourhood Development Plan (NDP)** will start at 8am on Saturday 25th August 2018 for a period of 8 weeks ending at 12 am on Saturday 20th October 2018.*

Mitcheldean Neighbourhood Development Plan has been developed to help deliver the local community's requirements and aspirations for the Plan Period up to 2026. The NDP has been created by listening to the views of the residents of the parish.

Mitcheldean Parish Council invites comments on the draft NDP. All responses received will be considered by the steering Group and the Parish Council to inform a revised version of the NDP. The revised version of the NDP will then be submitted to the Forest of Dean District Council, as the local planning authority, for examination by an independent examiner.
