

Search area for Lydney allocation





Appendix 2 – Lydney SNA

SNA unique number: 62 SNA name: Aylburton SNA area (ha): 678

National Character Area: Severn and Avon Vales

Landscape character: North end of the SNA is Drained Riverine Farmland and Grazed Salt Marsh, southern end is Unwooded Vale

Geology and soils: Quaternary silty clay tidal flat and gravel river terrace deposits overlaying Mudstone from the Triassic and Sandstone from the Lower Devonian. Predominantly loamy and clayey soils of coastal flats with naturally high groundwater with an area of loamy and clayey floodplain soil with naturally high groundwater to the north of the SNA.

Geodiversity: To be determined

Access: There is relatively little public access, particularly to the river side of the railway

Archaeology: Much of the area contains archaeology, including a Roman Villa.

Biodiversity: Lead Priority Habitat: Wet Grassland (as part of Coastal and Floodplain Grazing Marsh)

Around a sixth of this SNA is covered by the Severn Estuary SSSI, SPA and Ramsar (all coincident). There is one KWS designated for its bird interest, Alvington & Aylburton Meadow.

Priority Species: Brown Hare, Water Vole, Reed Bunting, Farmland Birds, Curlew, Herring gull, True Fox Sedge, Bewick Swan, Bats, Great Crested Newt and Starling


The ALC is very mixed, ranging from grades 2 to 5, with almost 90% of the soils being impermeable. Over half the land is grassland, of which around 7% is unimproved. Parts of the northern section are currently in ELS whilst some areas have just finished being in CSS, the extreme southern tip is also in CSS.

The SSSI in unfavourable condition and a HLS application aiming to restore SSSI/SAC/SPA to favourable condition would be given high priority, especially relating to salt marsh grazing and creation of intertidal mud.

The woodland is already in the Woodland Grant Scheme.

There are very few hedgerows to the northern end of the SNA, making it ideal for breeding waders and the northern section of the SNA is also well covered by a wet ditch network There are no powerlines near this SNA, which is favourable for waders and wildfowl.

Delivery Mechanisms: Current delivery is through HLS, Severn Vale Living Landscape project, and Green Infrastructure Plan e.g. developer contributions.
