#### 1. BACKGROUND

- **1.1.** Performance reports are presented to Cabinet on a quarterly basis. They demonstrate how the Council is performing in achieving its corporate priorities. The financial information, service information and local projects highlighted in these reports reflect any new or changing priorities to ensure the reports remain focussed on the most important performance messages.
- **1.2.** With the commencement of a new financial year we have taken the opportunity to present the information in a different way with the aim of making it more user-friendly for those who wish to understand more about how the Council performs.
- **1.3.** We acknowledge that the management information will be provided by Publica from November 2017 and that further work will be required to decide what performance information should be presented, however, we would be very interested to hear what you think about the prototype. If you would like to provide feedback please email the Corporate Support Team on <u>Corporate.Support@fdean.gov.uk</u>. All feedback will be considered when developing a final model.

#### 2. HIGHLIGHTS AND ISSUES FOR THE FIRST QUARTER

- **2.1.** Annex A provides a summary of the local projects and service information that is helping the Council to achieve its Corporate Priorities.
- **2.2.** Highlights and issues for the first quarter include:
  - 30 new affordable homes have been delivered 21 affordable rented units and nine shared ownership units, well on the way to exceeding the target of 60 for 2017/2018.
  - The percentage of household waste reused, recycled and composted is 63.06% against a target of 60%.
  - Processing of major planning applications within 13 weeks is well above the target of 60% at 83.33%. Processing of other applications (such as change of use, householder development, adverts, etc.) is also above the target of 80% at 89.51%.
  - Performance on the percentage of planning appeals allowed has deteriorated at 50% against a target of 30%. Four appeals were allowed and four dismissed.

#### 3. FINANCIAL RESULTS FIRST QUARTER 2016/2017

**3.1.** Historically, the first quarter performance does not highlight significant variances in the budget. However, in accordance with financial rule B4.2 the following areas are worth noting at this stage in the financial year.

- **3.2.** Legal Services is overspent by £37,631 due to legal and planning appeals. By the end of the year this overspend is estimated to be £125,000, which can be covered from the legal and planning appeals reserve if required.
- **3.3.** Income for recycling materials is £14,000 under budget. This is due to a market clamp down on fibre input to China which created a glut on the UK market. This was further exacerbated when one of the leading container companies went into liquidation. Prices for fibres dropped from £85 to £40 per tonne. This price is now recovering so we hope to reduce the shortfall over the rest of the year. Income from garden waste sales is higher than anticipated so should offset the shortfall in income for quarter one.

### Quarter 1 2017/2018

#### **Revenues and Benefits**

 £28,000 discretionary housing payments awarded compared to £9,000 during the same quarter last year



- Data matching exercises have identified housing benefit overpayments or £21,739 and council tax support overpayments of £21,195
- Work with the Single Fraud Initiative Service has led to two loss of benefit sanctions, two administrative penalties and two prosecutions.

#### Waste and Recycling

- Approximately **66,000** collections take place every week
  - There were **444** missed collections this quarter (34 per week or 0.05%). During 2016/2017 there were 2065 missed collections (on average 40 per week or 0.05%)
