TOWN AND COUNTRY PLANNING ACT 1990

The Tree Preservation Order DFTPO257 – Land to the North of 14 Loop Road Beachley

The Forest of Dean District Council, in exercise of the powers conferred on them by section 198 of the Town and Country Planning Act 1990 make the following Order—

1. Citation

This Order may be cited as The Tree Preservation Order DFTPO257 Land to the North of 14 Loop Road Beachley

Interpretation

- 1.1. In this Order "the authority" means the Forest of Dean District Council.
- 1.2. In this Order any reference to a numbered section is a reference to the section so numbered in the Town and Country Planning Act 1990 and any reference to a numbered regulation is a reference to the regulation so numbered in the Town and Country Planning (Tree Preservation) (England) Regulations 2012.

2. Effect

- 2.1. Subject to article 4, this Order takes effect provisionally on the date on which it is made.
- 2.2. Without prejudice to subsection (7) of section 198 (power to make tree preservation orders) or subsection (1) of section 200 (tree preservation orders: Forestry Commissioners) and, subject to the exceptions in regulation 14, no person shall—
 - (a) cut down, top, lop, uproot, wilfully damage, or wilfully destroy; or
 - (b) cause or permit the cutting down, topping, lopping, wilful damage or wilful destruction of any tree specified in the Schedule to this Order except with the written consent of the authority in accordance with regulations 16 and 17, or of the Secretary of State in accordance with regulation 23, and, where such consent is given subject to conditions, in accordance with those conditions.

3. Application to trees to be planted pursuant to a condition

In relation to any tree identified in the first column of the Schedule by the letter "C", being a tree to be planted pursuant to a condition imposed under paragraph (a) of section 197 (planning permission to include appropriate provision for preservation and planting of trees), this Order takes effect as from the time when the tree is planted.





Report for a Tree Preservation Order

DFTPO257, Land the North of 14 Loop Road, Beachley

Introduction

A Tree Preservation Order is recommended for 6 trees which are within an area recently receiving planning permission (P1949/20/OUT):

- T1 Oak (T5 on the survey plan)
- T2 Lawson Cypress (T11 on the survey plan)
- T3 Leyland Cypress (T12 on the survey plan)
- T4 Lawson Cypress (T13 on the survey plan)
- T5 Western Red Cedar (T14 on the survey plan)
- T6 Oak (T15 on the survey plan)

The trees will form the boundary of the settlement following development. A number of trees are present on the allocated land, mostly mature oak.

Desk Based Assessment

The site is outside of the settlement boundary as set out in the allocations plan. Following the granting of planning permission the tree will form part of the new settlement boundary.

Site Based Assessment

The trees are distinctive and prominent features of this part of Loop Road and form a boundary feature and screen when approaching from the north.

The trees are shown to be retained and safeguarded as part of the approved development. Some of the small trees within the group do not contribute significantly and therefore do not justify being included in the preservation order.

Consultation Responses

Planning application P1949/20/OUT has been subject to public consultation. No specific consultations in relation to making a TPO have been undertaken.

Discussion

Visibility: The trees are very visible from Loop Road and form a distinctive feature.

Individual Impact: The trees are mature. Some of the trees vary in quality individually. A small number of trees are not recommended for protection, due to their low individual value.

Wider Impact: The trees form part of wider countryside hedge field pattern and connect with the strong woodland character bordering the Severn Estuary.

Expediency: The site is subject to outline planning permission and the tree's play an important part in ameliorate the development site into the local character of the area. The trees are retained as part of the development and their contribution should be safeguarded.

A TPO is considered expedient.

Conclusion of Discussion: Six trees form an important feature together of high amenity value and therefore recommended for protection.

Alternatives to placing a Tree Preservation Order


Do nothing. The Council's permission will not be required prior to works to or the removal of trees. A felling license would be required for the removal of larger quantities of timber.

In the event of submission and consent of a planning application on the site, conditions may be imposed to safe guard the trees during construction and include them within a landscaping scheme. These may ensure short term protection of trees within the application site only, upon implementation of permission.

Recommendation


